The Chairman, Standing Cabinet Appointed Procurement Committee (SCAPC), Ministry of Defence, Sri Lanka on behalf of the Secretary, Ministry of Defence, No 15/5, Baladaksha Mawatha, Colombo 03, Sri Lanka now invites sealed bids from eligible and qualified bidders in Sri Lanka, or abroad for the "CAPITAL OVERHAULS AND SERVICE LIFE EXTENSION FOR HELICOPTERS OF THE SRI LANKA AIR FORCE" as follows;

- 3. The aircraft should be overhauled at the approved facility within a specific time period determined by the service agency (should be less than 180 days) and the said time period to be clearly mentioned in the bid.
- 4. It is mandatory requirement for a competent inspection team of the service facility/service provider, to carry out an **on-site inspection** as follows;
